INFORMATION & INSTRUCTIONS

RENEW **ONLINE**

Pay your renewal online quickly and conveniently using the FileLocal system located at www.filelocal-wa.gov. Select Renew a License in either the popup menu or under My License Forms. First-time users will create a new Business Account, add their locations, then link their existing licenses for Seattle and any other participating cities. Electronic payments for renewals can be made using a credit card or ACH Debit(e-check).

To set up a new Business Account and link your Seattle license, you will need to have your 16-digit WA State UBI number (sole proprietors may be able to skip the UBI question) and your City Account Number (CAN) for Seattle. This information is listed on the front of this form if it is in our system. Please email or call prior to setup if that information is not correct.

RENEWAL REQUIRED

No person, unless specifically exempted, shall engage in any business activity, profession, trade or occupation in the City without a valid Business License Tax Certificate (BLTC).

Effective 2019: Any person or business whose annual value of products, gross proceeds of sales, or gross income of the business in the city is equal to or less than \$2,000 and who does not maintain a place of business within the city shall be exempt from the general business license requirement. The exemption does not apply to regulatory license requirements or activities that require a specialized permit.

RENEWAL COSTS

The MAIN LOCATION fee charged for your renewal will be based on the taxable revenue reported in the most recent complete calendar year. If the filings for that period are incomplete or there is no tax history the minimum fee will be charged, and the department will bill for additional license fees as necessary. Fee information for each revenue tier by year is located at www.seattle.gov/licenses. Fees may increase each year with inflation.

MAIN & BRANCH

LOCATION: Any additional Seattle locations separate from the MAIN location are considered BRANCHES. If you do not have any locations in Seattle, or have only one, pay only the MAIN LOCATION fee, Each additional BRANCH located within Seattle city limits requires a separate license at \$10 per location.

- If you CLOSE any branch location, please notify our office of the branch closure by e-mail prior to renewal.
- DO NOT add locations to this renewal notice. A new BRANCH application must be completed for each new location online at www.filelocal-wa.gov or download the application at www.seattle.gov/licenses.

LATE **PAYMENT**

Renewals received postmarked after January 31 shall be subject to a late penalty. If a penalty is due and not paid, a license will not be issued until the penalty is paid. The following penalty amounts will be imposed and are due at the time of renewal (SMC 5.55.030):

- No penalty if received/postmarked on or before January 31; or
- \$10 if received postmarked after January 31; or
- \$20 if received postmarked after the last day of February.

REPORT CHANGES

Do not report changes on this form. Any changes to your business information should be requested by phone, e-mail or mail. If you have sold your business or changed the legal entity/structure, please contact us by phone or email. New entities and owners are typically required to submit a new application.

CANCEL A LICENSE

Closed, or no longer doing business in Seattle: Failure to renew the license will not close your account. Notification of closure is required in writing by email (tax@seattle.gov), mail, or via our online closure request form (www.seattle.gov/licenses). This is a separate process from notifying the State or other agencies of your closure. Any outstanding items on your account for periods prior to your closing date must be filed and/or paid to finalize the closure.

Moved outside of the City: You may be required to maintain your Seattle license and continue to file taxes. Please see our website for information about who should be licensed with us. If your business does not fit the criteria you may request cancellation.

Renew Your Annual Business License Before Dec. 31, 2022

All business license tax certificates expire at the end of each year.

Each year there is a potential increase to the business license tax certificate fee based on the annual Consumer Price Index. This has caused the annual license fees to increase for 2023.

Business license fees may increase based on reported revenue; actual filings affect fee

All new business license tax certificate applications are defaulted to the lowest license fee at registration. Once filing history is established the fee may be increased. The business license tax certificate fee is based on the prior completed year's annual reported gross revenue at the time of renewal. If the filing history is absent or incomplete, the fees charged will be the lowest tier. These fees may increase after tax filings are received. Businesses will be notified and billed appropriately for any additional license fees. Notices are sent annually.

SELF filing system ending; download needed documents before December 31, 2022

SELF (Seattle Electronic Filing system) will no longer be available for filing or paying taxes or paying business license fees in 2023. Register today on FileLocal. Once SELF is retired, users will no longer have access to their accounts or any documents within the system. If there are documents your business needs for its record-keeping purposes, you must download them from SELF before December 31, 2022: www.seattle.gov/self

Use FileLocal to manage your city business licenses and taxes online; create an account today

Take care of your business licensing and tax needs for Seattle and other cities in the Puget Sound region with FileLocal. Using FileLocal, you can apply and pay for a business license from any participating city or link your existing licenses. Once registered, you can file and pay taxes for one city or use the multi-city filing option, print your city business license, manage your city demographic information, and much more! Service fees may apply per city. Register your business now at www.filelocal-wa.gov.

Phone filing available for small businesses; there's a quick and easy way to file at your fingertips

Businesses with annual revenue under \$100,000 (or no business activity) may easily file via phone. Even if no tax is due, Seattle requires a tax return be filed reporting revenue. Businesses will need their Seattle customer number and an obligation number found on the tax form. To file by phone, call (206) 684-8484 and press "1" at the prompt. You cannot renew or pay for your business license by phone.

Payroll Expense Tax thresholds adjust for 2023; Consumer Price Index leads to changes

The Payroll Expense Tax, also called the JumpStart Tax, went into effect on Jan. 1, 2021 and currently applies to businesses with more than \$7,386,494 in annual Seattle-based payroll in the prior calendar year. It levies a 0.7% to 2.4% tax on the payroll expense of subject businesses based on their number of Seattle

employees earning \$158,282 or more in annual compensation. The rate of taxation increases as payrolls and compensation increase. The annual threshold and compensation ranges will increase for 2023 due to increases in the Consumer Price Index. The Payroll Expense Tax is filed and paid quarterly. Commercial Parking Tax rate increased in July; please adjust your collections

The City of Seattle's commercial parking tax rate increased on July 1, 2022, to 14.5% (0.145), per Ordinance 126488, an increase of 2%. The tax is equal to the parking fee multiplied by the parking tax rate. The revenue is used to fund transportation projects and programs. The tax must be collected from each customer who parks in a commercial parking lot or garage.
